

Mayor Fred Froehlich called the Regular Meeting to order at 6:00 p.m. on May 11, 2020 via teleconference due to COVID-19.

Members and guests sited the words to the Pledge of Allegiance.

In addition to Mayor Froehlich; Councilmembers: Matt Anthony, Tom Rieke and Jim Anderson were present. Councilmember Mary Wels was absent. Others in attendance included Vanessa Drill and Karen Fluegge (*Ledger*).

The agenda was approved on a motion which was made J. Anderson, which was seconded by M. Anthony, and which carried with all voting in favor.

The minutes of the regular April 13, 2020 regular meeting and April 20, 2020 public hearing were approved on a motion which was made by J. Anderson, which was seconded by T. Rieke, and which carried with all voting in favor.

The bills totaling \$56,380.95 were approved on a motion which was made by M. Anthony, which was seconded by J. Anderson and which carried with all voting in favor.

Councilmember Rieke noted that Mike Holmin was hired for the part-time mowing position at an hourly rate of \$13/hour.

Mayor Froehlich discussed that now is the time to make the city office safe. He discussed having a barrier wall built with a single plexi glass in front of the city clerk's office.

Making the city office safe with a barrier wall and plexi glass not to exceed \$4,000 was approved on a motion made by M. Anthony, which was seconded by J. Anderson, and which carried with all voting in favor.

Resolution #05-11-20 – Decertifying Individual Parcel within TIF District No. 1-8 was approved on a motion made by J. Anderson, which was seconded by T. Rieke, and which carried with all voting in favor.
